If one of the heirs is a surviving spouse and he/she wishes to transfer the vehicle to a new owner, this affidavit of heirship must be completed by him/her as well as all other heirs, but only the surviving spouse is required to execute a notarized bill of sale or act of donation. If there is no surviving spouse and the sale or donation is to a new owner, a bill of sale or act of donation must be executed by all heirs.

The applicant must surrender the previous title, if available.

Fees are \$68.50 for transfer of title, \$8.00 service handling fee, and license fees as applicable. If a UCC-1 form is submitted to record a lien, an additional fee of \$15.00 must be submitted. If any other type security agreement is submitted, an additional fee of \$10.00 must be submitted. If a lien was reflected on the title of the decedent, the original paid note or a release of lien on the lienholder's letterhead is required. If a consideration is expressed in a bill of sale, sales tax must also be computed or paid.
